Pilgrim Lutheran Church of the Deaf, 1233 South Vermont Avenue, Los Angeles, will host the Sixth Biennial Convention of the International Association (ILDA), which will be held at the Hilton Hotel, downtown, July 9-12.

About 400 delegates from deaf congregations throughout the United States, Canada, and Europe are expected to attend the three day event.

Registration will begin at 1:00 p.m. on Thursday, followed by a buffet dinner at which time the delegates will be welcomed to Los Angeles by civic and church officials. The Rev.Mr. Paul H. Dorr, pastoral advisor to ILDA and pastor of Emmanuel Lutheran Church of the Deaf, Milwaukee, Wisconsin, will preach the sermon at the opening worship service which follows the buffet dinner. The keynote address will be given by Rev.Mr.Roy L. Dahmnann, Pacific region of the Deaf, San Lorenzo, California.

Most of the day Friday will be set aside for delegates to visit Los Angeles tourist attractions. A special bus tour will offer the delegates a visit to Universal Studio. Pilgrim Lutheran Church and Pilgrim Towers, a residence for the deaf.

During the Friday evening session dramas with Biblical and Spiritual themes will be presented by various church delegations. Prizes will be awarded for the best performances.

Prizes will also be given for various artistic creations such as banners, needlecraft, painting and photography, which delegates may exhibit during the convention.

Association president, Joseph J. Kindred, Indianapolis, Indiana, will conduct the business

sessions on Saturday. One important item of business will be the presentation and selection of mission and charitable projects which the association will support during the next biennium. During the past two years it has been contributing to the support of Pax Natura, a ranch home for emotionally disturbed deaf persons near Edmonton, Alberta, Canada. The Rev.Mr.Robert A. Bauer, who is the founder and director of Pax Natura, will address the convention on Saturday and rreport on this project.

Mr. Elmer D.Francisco, Detroit, Michigan, former president of ILDA and now treasurer, will be the master of ceremonies at the banquet on Saturday evening in the Pacific Ballroom. The Rev.Mr.William A.Ludwig, pastor of Our Redeemer Lutheran Church of the Deaf, Seattle, Washington, will be the speaker.

The convention will conclude on Sunday morning with a communion worship service in the Golden State Room. The sign choir of the host congregation, directed by Mr.Charles Kotal of Cerritos, California, will lead the congregation sign-singing and will also present two special hymns: "God So Loved The World" and "Take My Life And Let It Be." The preacher will be the Rev.Mr.Arnold T.Jonas, Lake Hughes, California. Pastor Jonas served Pilgrim Church from 1948 to 1977. Under his pastorate the congregation built its present modern facilities and also sponsored the Pilgrim Towers project.

The International Lutheran Deaf Association was founded in Chicago during the first biennial convention in 1971. The "Founding Father," the Rev.Theodore W. Frederking, Phoenix, Arizona, retired pastor of Christ Lutheran Church of the Deaf, Cleveland, Ohio, will be honored as the Association celebrates its tenth anniversary at this convention. Other ILDA conventions have been held at Kansas City, Missouri, 1973, Washington, D.C., 1975, Spokane, Washington, 1977, and Memphis Tennessee, 1979. The 1983 convention will be at Pittsburgh, Pennsylvania.

Appleton, WI -- Gifted music students form around the country soon may have the opportunity to develop their artistic talents in a summer camp designed especially for serious musicians who are Lutherans. A feasibility study initiated by Aid Association for Lutherans (AAL) is now underway to setermine the need for the proposed Lutheran summer music program.

"One of the most important objectives of the proposed camp is to assist the church in affirming th importance of music and the arts to an individual's life and to life in the church," said Dr. Carlos R. Messerle, the director of the feasibility study. "Many summer schools provide fine musicat training, but we seek to offer first-class instruction in a Christian environment that will encourage full development of an indinidual's God-given talents."

Messerli recently was named director of the feasibility study because he has an extensvie background in music and education, including work on the Inter-Lutheran Commission on Worship, which produced the Lutheran Book of Worship. He recintly retired after a long career on the faculty of Concordia College, Seward, Nebraska, and currently is director of parish music at Grace Lutheran Church, Lincoln, Nebraska.

A survey now is being prepared to determine the interest in the project among Lutheran youth around the country, including students in Lutheran high schools. Misserli said he expects the first stage of the program to be designed for teenagers.

Although the proposal is just getting off the ground, Messerli asid a challenging, yet informal summer camp program, lasting six weeds or more, could be developed for the youngsters.

In addition to daily training in classical and contemporary music, students would be exposed to and participate in concerts, plays, art exhibits and a variety of recreational activities from swimming to hiking usually associated with summer camps.

"If we go ahead with the project, we would love to locate the facility near a lake, on a mountain or in a forest," said Messerli. "But at least initially, we might locate on a college campus because of the high cost of renting or purchasing in existing facility.

The feasibility study, which could cost in excess of \$30,000, should be completed in about six months. At that time, individuals who comprise the advisory council for the proposed Lutheran summer music program will determine whether to recommend development of the project. If the comp is developed, it could be ready by summer 1982.

"We've uncovered a high degree of interest

was one of six Michigan participants who attended the Section 504 Law Workshop arranged by the National Association of the Deaf in Chicago. The workshop lasted three days, beginning March 26th and ending on the 29th.

Clarence Schulz and his fellow workshop trainees shared their experience with participants from five other states. There was a total of 50 trainees from six states, Illinois, Indiana, Minnesota, Ohio and Wisconsin.

Those three days of workshop training gave the participants valuable information and materials which will enable them to better follow the guidelines of Section 504 because they now have a better understanding of the law in general. They will serve as resource persons in their home states. Mr. Schulz and the other Michigan participants are to work with deaf people and also train groups in their areas to further spread a better understanding of this 504 law. in developing a unique music program for Lutheran teenagers," said William Selle, assistant vice president-fraternal benevolence for AAL. "We're going to take a good look at the information being gathered by the advisory council and if we determine the need exist for the facility, we'll do everything we can to make it happen."





A Summary of the minutes of the Oct. 1980 ILDA Board Meeting – By-Law Changes & Resolutions

-condensed from the minutes of The Secretary of the International Lutheran Deaf Ass'n., Lester Ahls

The second and last regularly scheduled meeting for 1980 of the ILDA Board of Directors was held at The Lutheran School for the Deaf in Detroit, Michigan.

It began Thursday morning, October 23rd and ended at noon, Saturday, Oct.25th.

Summarized below are the high lights of important issues acted on, resolutions and by-law proposed changes, of which will be ratified at the coming convention in Los Angeles, CA this summer.

1. A new brochure on the ILDA, outlining its work and future goals is being readied.

2. Public Relations between ILDA and our churches must be improved.

3. Are Lay Ministers officially permitted to serve as regional advisors. Is such sanctioned by the Regional Advisory Council

4. Must Regional Pres.-Elects have to wait until ILDA Convention time to be sworn in and serve on the ILDA Bd. of Directors?

5. A permanent design for our "Right Hand Award" must be found soon. A contest will be started in which designs and drawings can be submitted.

6. Four students in one or an-

11. Pres.-Elect Charles Kotal and Editor Archie Marshall are among those planning to attend the Great Commission Convocation in St.Louis Nov.6-9. Mr.Kotal was appointed by his group in California and Mr.Marshall is taking a part in the program.

12. Proposed By-Law change: ARTICLE 7, SECTION A (Paragraph 1, line 4) ...

Add the words "or licensed lay minister" between the words "clergyman" and "serving". Moved by Kotal (Zimmerman). Opposed by Lyon, who felt that these positions should be filled by <u>ordained</u> ministers. Motion carried 5-1. This will be voted on at the July convention in L.A.

13. ARTICLE 6, SECTION C (3) Kotal (Treibel) moved that the remainder of the paragraph after the word, "years" in the first sentence be deleted. (carried).

14. The Projects Committee, in reviewing applications for scholarship grants of \$500 be awarded to the following: Rebecca J. Hannemann of Concordia College, Seward, Neb.; Beth Firnhaber of Concordia, Portland, Oregon; and James W.Boldman of Concordia Seminary, St.Louis,MO. All three students have strong support from their schools.

15. Rev.Don Zuhn reported that: Six of ten vacancies are filled. Only four churches are now without a pastor. With a gain of 174 new members, our synod now has 4,827 deaf members over the number reported in 1978. But there were 5,148 deaf members in 1970 which shows that we are just starting to make a comeback since then. Only 20% of our members partake communion (1 in 5). In the nation as a whole, 80% of the deaf population does not attend church. 17. Archie Marshall, editor of <u>The Deaf Lutheran</u>, because of <u>the urging and encouragement</u> received from the Regional Presidents and friends, withdrew his resignation plans. He will remain on the job as editor as long as the Lord and the readers want him to do so.

Of the \$5,000 grant received from Lutheran Friends of the Deaf, \$2,034.65 has been spent on equipment. That leaves \$2965. 35 for future purchases.

Editor Marshall and Business Manager Elmer Francisco have been working harmoniously togeth er, since Mr.Francisco took over the position from Mr. Russel Healey.

18. The theme,"BE OPENED" was adopted by the 1981 ILDA Convention Committee in Los Angeles.

19. The next meeting of the ILDA Bd.of Directors will be 2:00 p.m., Tues.,July 7,1981 at Pilgrim Lutheran Church,1233 S.Vermont Ave., Los Angeles, CA. This eliminates the need of a Feb., 1981 meeting.

20. A Historian Committee was set up. They consist of Rev. Frederking, Marion Van Manen, Clarence Schulz, and Joe Kindred

21. Editor Marshall was authorized to make purchases of 1. wax stripper, 2. camera, and 3.stabilization processor.

22. A questionaire will be put in The Deaf Lutheran for reader information on how the paper could be improved.

23. Secretary Ahls was granted permission to investigate costs of buying a copying machine (xerox) against the advantages of renting one.

24. C.Kotal said that besides the constitutional and by-law changes proposed and printed under paragraphs 12 and 13 of this article, there will be two more changes that we have discussed in other board meetings, namely Solicitations, under Article 1, Sec.C, and Active Members under Article 2, Section A. These proposed changes will

other of our seminaries has asked for financial support through our Scholarship Fund.

7. A profit of \$587.69 was accepted from the Dixie Region from our 5th Biennial Convention in Memphis in 1979.

8. An audited balance of \$6,361. 08 was reported by our Treasurer Mr.Elmer Francisco. However, the books of the Business Manager of The Deaf Lutheran has not yet been audited.

9. An additional 200 ILDA pins are on order.

10. No responses from any of the various foundations contacted by Secretary Ahls came with a promise for financial support for our Scholarship Fund. 1981 marks the 10th anniversary of the founding of the ILDA and hopefully this year we will be able to add 500 new members to our church.

A second convocation in St. Louis is being planned for Oct. 1981. All kinds of professional workers and pastors will attend. The goal is to find out why only 20% of the deaf population attend church. The ILDA will be the applicant for a grant from Aid Association for Lutherans (AAL) or the Lutheran Brotherhood to fund this meeting.

RESOLVED, that I.L.D.A. make membership a package proposal which includes a one-year's subscription to The Deaf Lutheran. Each year memberships will be as follows: Combination Membership (husband and wife) \$9.00 and individual membership, \$7.00. Membership renewals after the first year will be \$7.00 and \$5.00 respectively, subject to the Board of Director's review and approval. Thus such membership package earnings would be separate from solicitations for gifts and donations to I.L.D.A.

The Lutheran School for the Deaf in Detroit, Michigan is owned by an association of churches. Any congregation of the Lutheran Church-Missouri Synod, or congregation in fellowship with the Lutheran Church-Missouri Synod, may join the association and become one of the owners.

In making the announcement, Albert T.Pimental, executive director of the NAD, noted: "Historically, the purpose of credit unions has been to help members and groups to save and borrow money in small amounts. Many of these people might otherwise have difficulty in dealing with other sources. Credit Unions became popular around 1934, after the Depression. Originally, they were set up as co-ops for people who had a common bond so that members could obtain low-cost personal loans and have a safe and profitable place to save their money. Because most credit unions are administered by volunteers, interest rates on loans are kept low and all dividends goes to members, rather than pay for overhead and administrative costs.
