# What happened to THE DEAF LUTHERAN?

"What happened to <u>The</u> <u>Deaf</u> <u>Lutheran</u>? The last issue was February ... this one is for June! What happened to March, April, and May?"

The simple fact is that the economy caught up with <u>The Deaf Lutheran</u>. Rising publication costs, increased postage rates, and the difficulty experienced by some churches in paying for the blanket-plan subscriptions forced the decision to <u>suspend</u> publication until the ILDA could decide on a future course of action at its planned May meeting.

The Executive Committee reached these conclusions:

- Publication is to be resumed with the June issue, using the new format that had previously been planned for the March issue. A change in printer and in addressing systems made the new format necessary.
- 2) <u>The Deaf Lutheran</u> will be published bimonthly (six issues a year) on a trial basis until the ILDA convention in July 1983.
- 3) All subscriptions will be on an individual basis (\$3.50 a year) following the expiration of current blanket-plan subscriptions. You will be receiving renewal notices at that time.

# Convocation On Deaf Ministry

Previous articles in <u>The Deaf Lutheran</u> about the Convocation on Deaf Ministry in Madison, Wisconsin, last November failed to take note of the important role played by the Mill Neck Foundation (Lutheran Friends of the Deaf) in this project.

The suggestion that a convocation of this type be planned first came from the Mill Neck Foundation Board of Directors. Rev. Howard Schoenfeldt, a member of the board, voiced the board's concern that deaf ministry in the Lutheran Church - Missouri Synod take on a new vitality in reaching out to deaf people in all the world. The Mill Neck Foundation supported the Convocation on Deaf Ministry with a grant of \$10,000.

Pastor Schoenfeldt and Rev. Edward Rauff, former executive secretary of the Mill Neck Foundation, were members of the Convocation Steering Committee.

Our sincere gratitude to the Mill Neck Foundation for their continued active support to the church in ministry among deaf people.

Church - Missouri Synod. This is the first half of a \$8,400 commitment to assist in reaching out to deaf people in Hong Kong and in India.

The Lutheran Church - Hong Kong Synod has an active ministry for deaf people. First, there is the Mongkok Lutheran School for the Deaf with about 200 deaf children enrolled. Then there are two churches of deaf people (one in Kowloon with 207 members and another on Hong Kong Island with 92 members).

With our help (\$7,200) the LC-HKS can provide a full-time pastor for these churches.

## St. Mark Installs First Full-Time Pastor

On Sunday, Oct.18th at 4p.m., Rev. Kenneth E.Schnepp,Jr. was installed at a special service as the first full-time pastor of St.Mark Lutheran Church of the Deaf since this church was established 52 years ago in Towson, Maryland.

Although it had rained that afternoon, the spirits of more than 120 people in attendancewere not dampened. Joy and thankfulness was in the hearts of the many hearing and deaf friends who came from New York City, Philadelphia, and Washington, D.C.

Various people participated in the worship service. Mr.Daryl Gehlbach, vicar of Christ Lutheran Church of the Deaf, Washington, D.C. holding high the processional cross, headed the procession. Following him was Mrs. Lydia Waters, congregational president; Mrs. Gladys Krohn, elder; and Mr. John McKenny, treasurer. They all carried colorful banners into the sanctuary of the church. Visiting clergy from the immediate Baltimore area made up the end of the procession.

The sermon was delivered by the Rev.George Natonick, pastor of Christ Lutheran Church of the Deaf, Washington,D.C. The title of his sermon was, "Advertisers for Christ."He challenged everyone in attendance to remember our responsibility to bring the good news of the Lord, Jesus Christ to all people, especially to the deaf.

## Recent Oscars Award TV Show Experimented With New Service To The Deaf

ABC-TV recently tried a "new method for providing instantaneous closed captioning" for deaf TV viewers during its live coverage of the annual Oscar awards show on March 29th. It was the first "live" show ever captioned for the hearing-impaired.

Television columnists are bombarded each working day with about two pounds of publicity material from the networks, and much of it gets only a hasty glance before it is, ahhh, filed.

BUT THAT ABC announcement before show time was an eye catcher."Instantaneous" closed captioning of a live show! Hmmmmmmm. Impossible. Particularly when one knows that the National Captioning Institute (NCI) is located in Falls Church,Va.,and the Oscar event is held in Los Angeles.

Not to worry, says ABC. The tricky, instant transistion from the spoken word in L.A. to printed text in Falls Church and then on to the screens of some hearing-impaired viewers coast to coast will be handled - presto- by satellite and by a new computer-system breakthrough dubbed "Real Time."

Closed-caption printed text "crawls" along the bottom of the picture of sets equipped with special decoders that range in price from \$250 to \$300. Without the decoder, the closed-caption text can't be seen. Closed captioning of some programs on ABC, NBC and PBS has been around since March 1980. Those shows are designated via a "(closedcaptioned)" notation - the "Benson" comedy at 7p.m. Friday on Channel 2(in St.Louis) for example - in the TV logs at the end of this story and by a (CC) designation in one of the daily newspapers weekly TV Digest.

THERE IS NO big mystery involved with the captioning of a series like "Benson." A pre-taped, "canned" episode is shipped to the NCI technicians in Falls Church, who add the "invisible script" well in advance of its scheduled broadcast.

But a live Oscar presentation - how will that work? The new Real Time electronic mind boggler is the simple answer, said ABC.

"It not only turns spoken words into writing but will pick up the usage of the word and spell it right,"said Herb Wurth, an ABC publicity department spokesman for the Real Time project. "For instance, it will pick up the difference between a color that is 'red' and a book that is 'read.""

ABC believes the new system "of electronic computerized shorthand" could make it possible to offer closed captions on all live television such as news, the sporting events and a presidential State of the Union message.

BUT ALONG WITH that good news concerning the Real Time breakthrough, there was some bad news from NBC-TV for deaf viewers who have already paid out hundreds of dollars to equip their sets with the expensive decoders.

NBC recently informed NCI

president John E.D.Ball that it will drop the closed-captioning service at the end of the current TV season.

NBC said it has decided to pull out because of an apparent lack of interest on the part of hearing-impaired viewers, as indicated by the disappointing sales of decoders.

When closed captioning decoders were first made available, sales of 100,000 per year were predicted, but only about 50,000 decoders have been sold in the two years that they have been on the market. NBC says it is paying the NCI \$520,000 per year to add closed captions to such shows "Little House on the Prairie"and "Diff'rent Strokes" and now claims the lack of interest by the hearing-impaired community - estimated at 14 million people -makes that expenditure excessive.

NBC Vice President Irwin Segelstein said the decision was "not irrevocable" but he added that the network will stick to its plans to drop the NCI service for the time being.

CBS has never supported, the NCI's closed-captioning project, claiming that it is working on another type of advanced process that will make the NCI system obsolete.

\* \* \* Also on May 2nd Special Service is being planned in San Antonio, Texas. The deaf and hearing will join together in worship and to note the beginning of Deaf Awareness Week. A special service is now planned for San Antonio at St.John's Lutheran Church on Nueva. Pastor Reinap will be the guest speaker. A sign choir from Austin will add to the service. Signing and interpreting will be done by Pastor Reinap and Judy Hood. After the service noon lunch will be served.

In St.Louis(MO)County, Christian Hospital Northeast-No.west recently began a program to expand services to the deaf community.

Through the program, employees on all three shifts at the hospital's two divisions attended sessions on how to execute the basic sign language movements and communicate better with deaf persons. The hospital also initated a policy to provide the services of an interpreter free of charge to deaf patients in certain circumstances.

Interpreters will be provided for deaf patients in these situations: when they are treated in the emergency room, when they are asked to complete hospital admission forms; when they are asked to sign documents relating to surgical consents; and when they seek, receive, or are asked to provide medical information.

An interpreter can be provided in other situations, but the patient will be charged for the service.

Before the deaf interpreters arrive, employees will communicate with hearing impaired patients through two way note writing, basic sign language movements or with assistance from an employee in the hospital's audiology, ENG and speech pathology department.

Christian Hospital is one of the first hospitals in the area to educate its employees about the special communication needs of the deaf community on such a complete basis.

Instead, younger children go to school ready to read about spaceships and rockets, about countdowns and blast-offs. Instead of telling their teacher that they are ready, the right phrase is "All systems go."

The average child's vocabulary when he begins school still remains about1,500 to 2,000 words. But, as the way that people live today have changed, so the words they use also have changed. Many parents grew up in small towns or on farms. Then they moved to the city. Today their families are growing up in cities like New York or Los Angeles. Why would these boys and girls need to use such words as cow or chicken? These same children have little to use such words as wheat or cotton.

The words you use are important too. You, as one of God's people, express your faith and the things that concern you, by the words you use. By knowing the words you use in your prayer life and in your worship, you can better understand your need for God and your relationship to Him.

begun a new pastoral ministry to deaf people. Mr.D.Christudoss is working with the IELC School for the Deaf in Ambur while learning communication skills.It is hoped that he will soon be called and ordained as a pastor for deaf people.

The first half of the \$500 project for the Pax Natura Society has also been paid Pax Natura is becoming very familiar with members of the ILDA, with its work of rehabilitating deaf men who had been in institutions. Living at the rehabilitation house in Edmondton and working at the ranch nearby has been very good therapy. Christian love and care makes a big difference.

Scholarships totalling \$500 have been given to students in synodical colleges and seminaries who are preparing for full time church work in deaf ministry.

Members and friends of the ILDA are indeed helping Jesus's word - "OPEN!" touch the hearts of many people in many places, just as that word has already touched our own hearts.

careers of 140 of the graduates of the 1974 class in business administration were closely followed for five years. The researchers categorized the graduates into three groups: top-paid graduates whose salaries were\$75,000 the medium salary range with \$38,000 annually the low salary group with \$25,000 annually.At the end of the five-year period,he found that unhappiness in the high income group had increased dramatically. The low income group was happier with its family and life-style. The medium salary group also was ahead of the high income group in its satisfaction with life.
