# **AN OPPORTUNITY TO SERVE**

(Seldom in the past has THE DEAF LI-THERAN presented an article of such deep human interest as the following story by a member of our Seattle congergation. While being among the minority, the deafblind are nevertheless an important segment of the church at large.)--The Editor

He saw her sitting on the bus. A large button pinned to her coat indicated she was deaf and had poor sight. Being deaf himself, he sensed her loneliness and sat beside her.

Gently taking her hand, he signed, "I am Russell Crase. I am deaf, too." Thus began a friendship that would bring Linda McNair Sting to Our Redeemer Lutheran Church for the Deaf. Only one other deaf-blind person has attended this small congregation of hearing impaired members in Seattle, Wash.

Rev. William A. Ludwig, pastor of the Missouri Synod Lutheran Church for the Deaf in Western Washington did not find it difficult to minister to Linda and Ken Sting, the man she married several years later. He recalls his first encounter with a deaf- blind person while a seminary student at Springfield, Ill. "When I first met the deaf-blind man at Christ Lutheran Church for the Deaf in Jacksonville, Ill., I really did not know what to do with him," he said. "First, I observed how the elderly pastor, the deaf-blind man's wife and the other members communicated with him. Then shyly, I tried to talk to him and was amazed he could understand me as easily as any deaf person with good sight do," he said.

In Columbus, Ohio, his pastorate before coming to the Northwest, he served six deafblind residents at the home for the aged and infirm. "Thus, he says, "I was prepared to accept Linda and later Ken as full members of the church." Rev. Ludwig is pleased the members are willing to interpret for Linda and Ken and their deaf-blind friends who AN OPPORTUNITY (continue on page 2)

visit the congregation occasionally. "The deaf-blind must depend on others to 'hear' God's Word or learn what goes on at meetings and social functions," Rev. Ludwig said.

At church dinners, members describe the variety of food being served and will assist by placing the desired portions clockwise on the plate. A deaf-blind person's home is also simply arranged for easy accessibility. In unfamiliar places most blind will use their white cane to guide them. Occasionally, members will interpret for the young couple outside church fellowship. When Linda was hospitalized for recurring tumors (the cause of her blindness as an infant) and until the morning she died, interpreters from the church and the Lighthouse for the Blind where Ken works as a drill press operator were with them day and night.

To interpret for a deaf-blind person, the interpreters place their hands under the deaf-blind person's and sign or fingerspell the words being said. Not every person can do this. Some sign too fast; others too slow, and if not adept, the interpreter will not be relaxed enough to keep up.

I was privileged to prepare Linda for church membership. An one-hour teaching session often lasted more than two hours, leaving both of us exhausted. I used objects and teaching aids she could touch and feel to teach God's Word. A globe of the world to explain the word, "Kingdom" and blocks of wood in a knapsack to help her understand sin was like heavy burdens on our back and pushing pins in maps and letting her fingers do the walking through the wilderness or follow the footsteps of Jesus and Paul.

Linda and Ken wanted to be informed of everything that happened in the church fellowship. They could get quite upset if they were not informed. "Who had been baptized? How many visitors were at the service? Where was Pastor Ludwig, if he happened to be gone?" Then Priscilla Lords, Ted Brighton or Greg Deeth, who do much of the interpreting, inform them of the latest events. Ken, who has some vision, often watches the service on a Video Monitor.

One Sunday Linda came to church beaming from ear to ear. "My Ken is coming to Seattle and will work at the Lighthouse for the Blind," she told me. A few weeks later, she introduced her Ken to the entire congregation. When they annouced their forthcoming marriage, Rev. Ludwig received a letter from Linda's mother, Mrs. Alma McNair of Lander, Wyo. (Linda's childhood home) asking if someone from the church could help them with their wedding plans. "You are an answer to a prayer" Mrs McNair said when I phoned to offer my help. Kathy Mack, another member of the church, worked with me. We only offered suggestions, the final decisions were theirs.

We helped choose the wedding garments, flowers and cake. I addressed invitations, reserved sleeping accommodations for five families coming from out of town and even filled out their marriage license forms.

The congregation was as excited as the young couple. It was the first wedding in history of the congregation of a deaf-blind couple. At other weddings the bridal couple repeat their marriage vows with right hands clasped. Linda and Ken could not do this. They had to speak through an interpreter. "I had to invent a new way to 'tie' the knot," Rev. Ludwig said. He first had them repeat their marriage vows and then took the yoke worn around his neck (symbolic of his office as an ordained minister of the Word) and tied it around their clasped hands. At that very moment, they were joined together as one.

LInda and Ken had only three short years together as man and wife and they lived them as an eternity. They were eager to show the members and friends their apartment and the electronic gadgets to help them live in a world of silence and darkness. Ken installed smoke detectors that flash off and on in case of fire. The doorbell works the same way. Around Ken's waist is a vibrator that also let them know if someone is at the door.

Books and magazines are in Braille. Marion Reese, a volunteer Braille worker, types in Braille the titles and dates of their church offering envelopes. The Bible comes in many volumes, each one as large as a metropolitan phone book, making it cumbersome to carry. The interpreter usually signs the Bible verses being read.

The congregation seeks ways to involve the deaf-blind in the Lord's service. They are encouraged to give of their offerings to God and are asked to attend all workshops and other programs of the congregation.

There are limitations as to what the deafblind can do to serve the Lord. They can't see to drive a car and must travel around the city on buses. An interpreter would have to

be present if they hold an office. They can't see well enough to do secretarial work.

It does bother Ken that his deaf-blind friends are not active in <u>church</u>. "I try to tell them about Jesus" he says "but they tell me they are too busy." Rev. Ludwig, who is also deaf, knows full well the frustrations of a deaf ministry says, "Just keep on witnessing and pray. God's Word will reach them."

Since both parents of the couple live out of town (the Harold Stings in Sebwaing, Mich. and the McNairs in Wyoming) the young couple would go to the members for advice and counseling. Ted Brighton and I could always tell when we would be asked to help them. The moment they walked through the door they would ask, "Where is Meta?" And Ken would say, "I want to talk to Ted." They asked advice on Income Tax problems, Linda's health when she lived and problems in their apartment or even to solve a domestic problem.

When Linda was hospitalized my name was placed on the volunteer emergency list. Ken would phone through an interpreter to inform me of Linda's progress and I in turn would reply the message to their parents out of town. The hardest thing I had to do was to inform the parents of Linda's death and to help Ken with the funeral arrangements.

Russell Crase, who had befriended Linda on the bus, came to her funeral, too. She was my friend," he said. "I was the one who brought her to my church. I will miss her very much." Russell's words are echoed by all the members of the congregation, who had come to love Linda very much.

Ken comes to worship alone now and the church members continue to minister to him through the beautiful language of signs. Ken's one wish is that more deaf-blind people would come to his congregation which will give Rev. Ludwig's members more opportunity to serve the Lord.

## **JEHOVAH'S WITNESSES: WHO ARE THEY?**

It has been brought to my attention that some members of Holy Cross have been approached by the Jehovah Witness people. I feel it is important that you know some basic facts and teachings of the Jehovah Witness, so if they come to your door, you will know what they are talking about. The J.W. are a big challenge to Christians for several reasons. Their teachings are opposed to the Gospel of Jesus Christ. They are opposed to the Christian church and they say the Christian church belongs to the devil. They deny that Jesus is true God and deny the work of the Holy Spirit. They also say that their teachings are the "only real truth" that came from the Bible.

Let's examine some of these statements by the Jehovah Witnesses in the light of divine Scripture:

 The Christian church belongs to Christ, not the devil. It is His body. Find this in Romans 12:5. Christ loved the church and gave Himself for it. Ephesians 5:25 Christ is the head of the body, the church: Colossians 1:18 The church is the bride of Christ: Revelation 22:17; also read the parable of the wise and foolish virgins in Matthew 25:1-13.
Jesus Christ is true God. "All power is given unto Him: Matthew 28:18 ". . . and one Lord, Jesus Christ, by

whom are all things, and we by Him." See I Corinthians 8:6 Being made so much better than the angels as He hath by inheritance. Hebrews 1:4

3. The Jehovah's Witnesses deny the work of the Holy Spirit. And they were filled with the Holy Ghost, and began. . . Acts 2:4 The promise of the Holy Spirit as written in John 14:16-18 The Holy Spirit will guide you into all truth. John 16:13 ". . the spirit quickeneth; the flesh

profiteth nothing . ." John 6:63 The first chapter of Genesis mentions the Spirit of God moving over the face of the waters.

The Jehovah Witnesses are well known for their witnessing on street corners and knocking on doors. They witness because they are working hard to earn their salvation. Because they do not believe in hell, they have no fear of eternal punishment but they are afraid of not meeting Jehovah's standards for salvation. ### Lord's Supper for Members Only

Dear Pastor Larsen:

Why does your Lutheran church only give the Lord's Supper to members--and not to anyone who comes? Jesus gave the Lord's Supper for everyone--not just Lutherans. I do not agree with your rules. --A Lady Who Wonders

#### The Pastor Answers:

The church, like many other organizations, has certain rights and privileges that are set aside for members only. Some of those privileges are for Christian weddings and funerals, voting at meetings, and the Lord's Supper.

In a similar way, only members can vote in any kind of club meeting. Only lodge members can have a lodge funeral. Only citizens of the United States can vote or run for office. Only people with a drivers' license can drive a car. Only members of an auto club (as AAA) can get free maps, etc. Every group or organization needs some rules to live by, or we would have a big confusion. Non-members who do not support a group would be running the business of those people who do support it, which would be unreasonable.

With the Lord's Supper, our rules are not meant to keep anyone away from this blessing of Jesus, but rather to keep the celebration of the Lord's Supper from becoming cheap and losing its meaning.

I think that when you visit a Lutheran church if you are not a member, you will find that you may speak with the pastor about your faith in Jesus and ask that you receive the Lord's Supper. If you have accepted Jesus as your Savior and are willing to say so, and if you believe and understand the meaning and purpose of the Lord's Supper, that pastor will welcome you to share it with the members.

But, if you have no idea what the Lord's Supper is for or what it means, or even worse, if you have no faith in Jesus as your Savior, but just want the Lord's Supper so you won't feel left out, then it would be most wrong for the pastor to give it to you.

This is not our idea--look at what God says in Paul's first letter to the Corinthians, chapter 11, verse 29: "For anyone who eats and drink without recognizing the body of the Lord eats and drinks judgment on himself. That is why many among you are weak and sick, and a number of you have died."

A person who eats and drinks the body of

the Lord in the Lord's Supper without understanding what he is doing or without faith in Jesus, will bring judgment on himself. It would be wrong and careless for a pastor to give it out to anyone, even non-believers or people who have no understanding of what is going on. For their own good, they should not take it.

The reason we can and do give it to members is because members have been taught the meaning of the Lord's Supper, and to become a member, they are to publicly proclaim their faith in Jesus as their Savior and their understanding and agreement of what Jesus teaches about the Lord's Supper. We have no way of looking in their heart to see if they truly believe, but then we have done all we can to help them understand and believe.

Remember, when Jesus first established (began) the Lord's Supper. He shared it with His disciples only--on the night before He died. He didn't pass it out to soldiers, to curious people, to everyone, like giving out sausage samples at the state fair.

In the future, if you visit a Lutheran church, speak with the pastor and assure him of your belief and understanding in Jesus and the Lord's Supper--and you will be welcome to share it, too.

#### **Stewardship and Unbaptized Pocketbooks**

A story is told about a certain pastor baptizing one of his new converts in a river. As the new Christian approached his pastor,



he suddenly remembered something. "Just a minute," he said as he ran back out of the water, "I forgot to give my billfold to my wife.'' "Come back here,"

shouted the pastor. "There are already

enough people in our church with unbaptized pocketbooks."

Proverbs 3:6 says, "In all your ways acknowledge God, and He will direct your paths." It is possible for us to think right about God, accept all the things the church teaches, be strict about rules for Christian living, be eager to preach to other people, to know the Bible from cover to cover, and and at the same time to close our minds to God's teaching on the Christian stewardship of our money.

Jesus was a bother to people who didn't want to hear about God's demands on their money.One verse of every six in Matthew, Mark and Luke talks specifically about people and their possessions/money. Almost one-third of Jesus' parables talk about money.

If you feel uncomfortable when the church talks about giving, then you probably have a problem in your heart. The Bible teaches clearly that God expects us to give and to support the church. We believe that Christians should give a certain percentage of

The agreement stipulates that if the school has not moved to a new site by the 1984-85 school term, rental space will be provded for one year.

The school, which has operated on the same location since 1892, is seeking a new site and plans to reorganize, eliminating some secondary programs.
