you asked. This is true as shown by a survey conducted by one professor at a college who asked his students the question. same The startling answer revealed that Jesus Christ was for 14th tied place! Likewise, if we were to ask what was the most important events, many would say, "the landing on the moon; or the atomic bomb or perhaps even the

Revolutionary war." No matter how important we may feel these events and persons may have been, the truth is that none of them compare with the Advent of the birth of the Saviour of the world, Jesus Christ and His resurrection on Easter.

ILDA MISSION PROJECTS UPDATE

As we go to press, approximately five months remain before the 1993 convention opens in Austin, Texas. ILDA Treasurer Dennis Konkel reports that as of January 16, 1993, receipts for ILDA Mission Projects since the last convention at Toledo, Ohio have reached \$8,534.97 or approximately 42.6% of the \$20,000 goal set two years ago.

While a goal of \$20,000 does not seems to be an impossible achievement to attain, we also realize that the economy the past few months has been hard on many families and may account at least in part for the disappointing results so far. But there is still time to at least improve before we gather in Texas.

A barometer showing "how we are doing" appears elsewhere in this issue. (See Page 2.)

After a long ordeal with cancer that devastated her body, but never her cheerful spirit, Mildred Mary Francisco, 70. of Spokane, Wash., was called home by our Lord on Monday, Dec. 21 to celebrate Jesus' birthday in heaven. Millie, who would have been 71 in eight more weeks, was looking forward with her husband, Elmer to their 50th wedding anniversary on April 10 this year.

A native of a remote area in southeastern Montana, she attended a one-roon school in Camp Crook, S.D., and by the time she was 13, entered the South Dakota School for the Deaf, graduating in 1941. She was one of the first deaf people to be employed at Boeing in Seattle, Wash., during WWII. She met her husband during church services in Billings, Mont. in 1942 and the couple was wed a year later ar Poulsbo, Wash.

The couple moved a number of times during their years together, to Montana, North Dakota, Wyoming and back to Montana, again and also Washington. Before settling down for good in Spokane, they accepted one more challenge by moving to Detroit, Mich. in August, 1978 where they were houseparents and counselors at the Lutheran School for the Deaf until their retirement at which time they returned to their home in Spokane.

Active in her church, the International Lutheran Deaf Association, the Northwest Regional Conference of the ILDA and the deaf community wherever the couple happened to reside, Millie could always be counted on to help when something needed to be done. She was also president of her local LWML as well as financial and church council secretary.

Services were conducted on Thursday, Dec. 24 at Faith Lutheran Church, Spokane, with Rev. Martin Hewitt officiating. Surviving her are her husband, Elmer, and three children, Donna of Spokane, Patricia of Bozeman, Mont:, and Ronald of Lyons, Ore; seven grandchildren; three great grandchildren; her mother, Fern Catron, 92 of Lewistown, Mont.; three brothers, Clyde, Bob and Rex, and one sister, Helen and a number of nieces and nephews.

BENJAMIN J. BEAVER

Benjamin (Ben) Beaver, 100, of Detroit, Mich. passed away Sept. 8, 1992 at the Elwyn Institute, Philadelphia. A native of Illinois, he spent most of his life in the De-



troit area, where he was employed by the Ford Motor Co. for 42 years, rising to the rank of engine inspector. A fighter all his life for the rights of the deaf community, he and his brother, Ralph, were the first deaf people to be issued drivers' licenses in the State of Michigan.

BENJAMIN Beaver His response to periodic considerations by state law

makers to restrict the rights of deaf people to operate automobiles results in the organization of the Detroit Association of the Deaf (DAD) and the Michigan Deaf Drivers' Defense Fund, which remains to this day. He was an avid athlete and baseball players and was always involved in helping others.

Ben Beaver was a member of Our Saviour Lutheran Church, Detroit, for many, many years and attended conferences of the Great Lakes Regional Conference.

Services were held on Sept. 11, 1992 with Rev. Clark R. Bailey officiating. Interment was at Grandlawn, Detroit.

PROPOSED CONSTITUTIONAL CHANGES

Greetings to all our supportive ILDA members in Jesus' name!

According to ILDA Constitution, Article XXI, all resolutions of amendment, modification, alteration or repeal must be presented to all congregations, fields, and persons involved in pastoral ministry with deaf persons of the Lutheran Church--Missouri Synod at least ninety (90) days prior to the ILDA convention.

As requested for our certification on Internal Revenue Services (IRS) 501 (c) (3) status in our continuing application for Synod auxiliary status, two additions are asked to be made into our ILDA constitution.

1. Addition as a second paragraph to article IV.

"The Association is organized exclusively charitable, educational, religious for or scientific purpose within the meaning of section 501 (c) (3) of the Internal Revenue Code."

2. Addition as second paragraph to Article XVII.

"Upon the dissolution of the Association, the Association shall after paying or making provisions for payment of all the liabilities of the Association, dispose of all the assets of the Association exclusively for the purposes of the Association in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the qualify as an exempt or-

ganization or organizations under section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any Such assets not so disposed of by the Court of Common Pleas of the county in which the principal office of the Association is located, exclusively for such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes."

Also presented will be the approval of the ILDA Board of directors to set up an ILDA Mission Endowment Fund. The fund will be used as designated for specific purposes or missions in memory of pastors, members and friends called to heaven to be with Jesus. Respectfully submitted, LARRY M. GORTON, Chairman
