"WE THE PEOPLE, of the United States of America, in order to form a more perfect union, to establish justice, to insure domestic tranquility, to provide for the common



defense to promote the general welfare and to secure the blessings of liberty upon ourselves and our posterity do ordain and establish this Constitution of the United States of Amer-

ica."

The above paragraph are the words penned by Thomas Jefferson more than 200 years ago and are contained in the Preamble to the Constilives in a country where we are guaranteed freedom of worship, freedom of the press, and freedom of speech should ever be grateful to the Lord. Liberty is a priceless possession for which we have, as a nation, paid very dearly since our country was founded by our forefathers, Still, it is often abused. Contrary to what many people think, it does not mean that all moral restraint can be set aside, nor that law-breakers should go unpunished.

Members of the "gay" community are very wrong in assuming that just because this is a land of freedoms, their way of life should be given position of respectability and their views should be allowed a hearing in our schools. In the same way, producers and distributors of pornography completely misunder-

AUTHORITY OF THE BIBLE

The rejection of the Bible by unbelievers since time began has always been a challenge for Christians and a reason for continued prayer that the spirit of God might change their hearts to accept the one and only way of salvation.

In the world of Christianity there still is a divided opinion as to the partial or complete acceptance of the Word as being divine. The Church of Rome (Catholic) states dogmatically (by their own authority) that "the supreme authority instituted by Christ to decide about the Truth of Christianity as contained in the Bible is to be found in the hierarchy of the Church under the infallible and supreme leadership of the Pope of Rome."

This was, of course, challenged by the

great leader of the Reformation, Dr. Martin Luther. When brought before the judges of Worms he said: "Unless I am convinced by the clear testimony of the Holy Scriptures I cannot and will not recant. Here I stand. I cannot do otherwise. So help me, God."

As a result, true Lutheranism follows the divine mandate: "All Scripture is given by inspiration of God and is profitable for doctrine, for reproof, for correction, for instruction in righteousness that the man of God may be perfect, thoroughly furnished unto all good works. (See 2 Timothy 3:16-17).

There is a danger creeping into the ranks of Christianity regarding the authority of Scripture. It seems in the minds of some readers of the Bible today that there is a higher authority for the direction of our

"MAINSTREAMING UNFAIR TO DEAF CHILDREN"

The recent demonstrations at one state school for the deaf have resulted in twc articles in a major newspaper ("Students, Parents Protest School for the Deaf," and "Deaf Group: Mainstreaming Wrong Route.") The second "touched" the important issue facing the deaf community.

I am a deaf adult who was "mainstreamed" long before the term was even developed. Speaking from my own experience and observations over the past 40 years, I would not inflict mainstreaming on my worst enemies. While I have no personal regrets looking

stand what's involved in liberty if they claim their rights are being violated whenever the government takes action to curtail their activity. The liberties guaranteed to us in the Constitution are not a license for us to harm other people or to corrupt their morals by sinful behavior on our part. It has often been debated just what the language would have looked like in the Constitution if the author could have foreseen how those liberties would have been interpreted 200 years later.

We only experience true freedom when we operate within the limits of God's laws. Anyone who advocates or practices evil under the flag of liberty is deceiving himself and others. They may be convinced they are enjoying life, but in reality, they experience feelings of frustration, emptiness and dread. They are like the false teachers of Peter's day who promoted unholy contact in the name of Christian liberty. In truth, they are themselves prisoners, enslaved to their practices which are taking them to their own destruction.

During this month of July, as we celebrate the 218th anniversary of the signing of the Declaration of Independence on July 4, 1776, let us, as members of God's family, ever be careful to maintain a correct concept of liberty. Remember, if we mis-use our freedom, we will lose it.

"While they promise them liberty, they themselves are the servants of corruption." See 2 Peter 2:19. back, I wouldn't want any deaf child to have to endure the isolation, communication barriers and social obstacles that exist in the hearing world for the deaf.

The concept of mainstreaming was invented and supported by hearing parents, hearing educators, hearing social workers and hearing bureaucrats for their own convenience and peace of mind.

This same attitude has guided the majority throughout history. The whites in America just knew what was best for the Native Americans, as did the Catholic Missionaries in South America when dealing with native populations. The hearing majority cannot be bothered to listen to deaf individuals and their requests.

I challenge any hearing parents, teacher, politician or social workers to attend a class being instructed in American Sign Language (ASL) for one week and then say mainstreaming deaf students in an oral environment is fair and equal.

Please remember that like immigrants to America who have the ability to learn English, for most deaf children mastering English and speech is not a feasible option.

Please listen to us when we ask that our deaf children not be forced into mainstream programs just for the convenience of hearing educators and administrators.

BUILDING PLANS POSTPONED

Calvary Lutheran Church, Des Moines, Iowa has had plans to construct an addition to its building for many months. A questionnaire was sent out to members early in the year with about 21 returned. Results showed less than 15 were in favor of the addition and even fewer would be willing to support it.

With this information in hand, it was moved and passed to suspend construction until a future date. Architectural fees were returned to the church and a letter was sent to the LWML to turn down a gift of \$10,500 that had been offered.

It is still hoped, however, that the addition will eventually be built but at this time, it is not known when.

RYNEARSON GOES TO FAR EAST

One of the traveling-est people we know of has to be Dr. Rodney R. Rynearson, Counselor of Deaf Ministry in St. Louis. We saw him twice in March and April in Chicago, where we attended the centennial worship service and the ILDA board meeting. He had just returned from a visit to Macau and India, where he had an opportunity to see first hand what God has done for deaf ministry in these far away lands.

He was welcomed in Macau a bit after 2 a.m. after a 27 hour flight by Rev. Louis Jasper, who serves at Concordia Special School there. A meeting with some government officials brought out some very good news: a pledge of regular support for the educational program at the school was made.

Another school visited was the Hong Kong Lutheran Deaf School. With the Chinese New Year looming, only a few students were there, but Pastor Rynearson describes the school as a 'fantastic' place, with staff very friendly and helpful.

Following a visit to the U.S. Embassy and the Lutheran Church of All Nations, he took a flight to Madras, India via Singapore. There he was taken to visit two schools in Vellore and Pernambut. Also visited were schools in Ambur. The pastor mentioned that renting a car, complete with driver, gas and his expenses for five (5) days was \$150 (try and do that here in the U.S.! Ed.)

Pastor Rynearson was the speaker at two events, one before about 60 teachers from four Lutheran Schools and another to preach at a local hearing church.

One of the interesting aspects of his trip was a tour of a watch factory where about

lives than the Bible. One might rightly ask if the social order of the day decides what is right or wrong. Here are a few examples: Do the statements of the Bible really speak clearly about the matter of abortion and euthanasia? Are our morals in business directed by God's Word? Is sin really a transgression of God's commandments and merits His punishment or are sins just aberrations of the day?

God's Word is the final authority of Christians and may we ever hold that Word Sacred. 2,000 people are employed. He reported that 150 deaf were working there, or about $7\frac{1}{2}$ of the work force, which seems remarkable when you think about it.

It has often been said "that half of the world does not know how the other half lives." This was certainly demonstrably true when Pastor Rynearson described one location with a room 10'x14' sandwiched between two factories. A door to the rear leads to a 4'x4' kitchen and another door leads out front to an open space of about 4'x10'. In that small room with a single light bulb, 12 deaf and 13 blind children study, play, eat and sleep. It is their only home, as their parents have abandoned them. Yet, they had a fantastic demonstration program telling of the love of Jesus, says the pastor.

With many dedicated Christian people working in four deaf schools, three blind schools amd six other institutions, the blessings of God were plainly evident, for which we give God thanks.

Holding its first meeting since the last convention in Austin, Texas, the Executive Committee and Board of Directors gathered at the Drury Inn in Schaumburg, Ill., a suburb in northwest Chicago to map plans for

Because 1995 will be an election year for officers in the ILDA, President Madding urged all regional presidents to be sure and send in election results to Lester Ahls, editor of THE DEAF LUTHERAN, for publication, preferably by Jan. 1, 1995.

The Articles of Incorporation of the International Lutheran Deaf Association were approved by the Secretary of State of the State of Missouri on Dec. 20, 1993. Incorporation was one of the pre-requisites to obtaining either Auxiliary Status or RSO (Recognized Service Organization) status in the Lutheran Church--Missouri Synod. The application of the ILDA for such status in the Synod has been given to Dr. John Schuelke of the LCMS Board of Directors. As of the time of the Board meeting in Schaumburg on April 15-17, no reply had been received. A motion by President-elect Larry Gorton to have the Articles of Incorporation made a part of the minutes of this meeting were carried.

A final decision on ticket prices for the 1995 convention and costs for tours have yet to be made and hopefully, will be announced in the pages of this publication as soon as they become available. The meeting recessed to allow members to tour the Hyatt Regency Hotel where the convention next year will be held. Every one should find the accomoda-

TEENAGERS AND SEX
